In the Battle of Antietam, General Robert E. Lee's first invasion of the North was ended on this battlefield in 1862. More men were killed or wounded at Antietam on September 17, 1862, than on any other single day of the Civil War. Federal losses were 12,410, Confederate losses 10,700. Although neither side gained a decisive victory, Lee's failure to carry the war effort effectively into the North caused Great Britain to postpone recognition of the Confederate government. The battle also gave President Abraham Lincoln the opportunity to issue the Emancipation Proclamation, which, on January 1, 1863, declared free all slaves in States still in rebellion against the United States. Now the war had a dual purpose: to preserve the Union and end slavery. Antietam National Battlefield, along Antietam Creek in Sharpsburg, Maryland, commemorates the American Civil War Battle of Antietam, September 17, 1862.



## Military Minutes - July & August 2015

#### July 18-19, 2015 Charlton Park-Hastings

Fortunately, a couple of us who shall remain anonymous, were able to get a new watch since Sarg had no longer need of it. He had already lost all of his pay at games of chance anyway and we sold his shoes to the barber. That part is not in the letter we sent to his parents.


For the battles we trekked out to the high meadow, gratefully stopping frequently to get some water in and take a break. Not many of the military had problems with the heat, thanks to getting water in all the time and the assistance of the civilians who passed out Gatorade, water and ice. Saturday we were the victors, driving the Sesech off the field. Sunday we took our turn getting routed. Have given my all for the cause, the company command fell to the 1st Sergeant, who promptly tried to save the company, or what was left. He became a casualty, and alas, only two survived. Something about going for help. Beside a couple of intense storms, it went well. It was again my privilege to lead, or be in the ranks, of the 7th Michigan Volunteer Infantry, Company B.

#### Rededication of Loomis Battery Cannon – State Capitol



The following email was received from Jim Kirschensteiner regarding a planned event in Williamston, MI. It is my understanding that it has already been passed on to the members of our military; I reprint it here with Jim's permission in the view of alerting the remainder of the club membership to this opportunity.

Gentlemen,

I received a call today from a fellow by the name of Earl Wolf who lives in Williamston. He was calling to see if the 7th could provide a few reenactors for Williamston's annual history day. He said he talked to Anson last spring about this but had not heard anything since. He tried to contact the 7th via our website, but had no success there (need an email address linked to the web site). Then he sent a letter to our PO Box, but got no response there either. He has been frustrated tried to reach someone in the 7th to talk to. He said he talked to someone that knew I was a reenactor and that's how he got my phone number.

Williamson's annual history day is Sunday, October 4th and will be held from 1 to 4 pm. He said they set up several stations around town such as at the cemetery, the museum, the city hall, etc. and people go from station to station to learn about the history of Williamston, Michigan, the area, etc. He said they would like to have a few Civil War reenactors stationed at the city hall near a new historical marker commemorating Michigan soldiers in the Civil War. He said we could set up a small encampment (a few tents for example) and talked to the visitors as they come by about the Civil War, life in camp, battles, etc, He said if we want to we could fire a few volleys from time to time as a demonstration and have our flags there. Civilians could talk about civilian life during the Civil War period. He said that many (about half) of the visitors would be high school students who get extra credit for visiting each of the sites. It sounded like they may write a report on what they learned to get the extra credit. Don, this sounds exactly like many of the school programs we do, like Ovid for example.

Time is fleeting as they have a city board meeting coming up soon and I told him I would get back to him after talking this around some. It seems like we could and should have a few people there to do these sorts of events. After all, this is part of what the 7th's mission is. I can be there as a soldier. Therefore, I am asking our Captain and First Sergeant to canvas the troops quickly to see if we can get a few guys there, maybe four or five, and our civilian chair person (Katie) to see if we can get some civilians there too. In my talk with Mr. Wolf, he said anything ranging in size from the Grand Ledge living history done on the island to the Jackson Cascades muster:) would work for them. I think a school type program would be about right.

Please let me know as soon as you can, so I can get back to Mr. Walsh. He has been frustrated enough trying to contact the 7th and deserves a response about what we can or can't do.

## ONE OF THE MEN OF COMPANY B: PRIVATE PERRY ABBOTT

While I love reenacting, nothing brings me closer to the experience of the men who were there than handling period materials. I have a small but growing collection of autographs, documents, cartridge and cap boxes and various trappings that accompanied the civil war soldier. As time allows I will try to include articles in the newsletter with these materials and some context and history for them where possible. This month's contribution is the discharge of Pvt. Perry Abbott.

Perry Abbott was mustered into service in the 7<sup>th</sup> Michigan Company B in Detroit, Michigan as a recruit by Capt Harty?, on the 14<sup>th</sup> of February, 1862 for a three year enlistment. Pvt. Perry is described as being 19 years old, standing 5 feet 4 inches tall with dark complexion, raven hair and blue eyes. His listed occupation at enlistment was "farmer". Private Abbott was born in Halstren, Germany. He likely fought in Yorktown, Fair Oaks, Peach Orchard, Savage Station, White Oak Swamp, Glendale, Malvern Hill, 2<sup>nd</sup> Manassas, Antietam and Fredricksburg.

Townsend's book states he was discharged after wounds at Gettysburg. But a portion of his discharge materials in my possession show that he was discharged due to disability March 14, 1863, before that battle. One can guess that his wounds were from either Fredricksburg or Antietam but this is unknown and given his departure location was likely departing from a hospital where he stayed for some period.

At his date of discharge. Pvt. Abbott had not been paid since June 30 of 1862 (8 months and 13 days before!) He was paid at 13 dollars per month, credited 14.73 to travel from Baltimore, MD to Detroit Michigan a trip that was assumed would take 34 days. He was credited for 45.50 in unused uniform allowance and 17.00 for "rations". He was paid out a total of 161.81.

The documents at right are a certificate to receive his pay and an accounting of his credits and debits on discharge.

# Strange and Fascinating Facts About the Civil War Taken from *The Civil War; Strange and Fascinating Facts - by Burke Davis*

The war was touched off by an artillery duel between Confederates ashore at Charleston, South Carolina, and a garrison of Federal troops at Fort Sumter in the harbor. Commander of the handful in blue was Major Robert Anderson, whose father-in-law was a Governor of Georgia. Anderson had been so adept as an artillery pupil in is days at Wets Point that his instructor had broken tradition to keep him as an assistant at the West Point. The Confederate commander who directed the firing on Fort Sumter was the instructor himself, General P.G.T. Beauregard.

Albert T. Bledsoe, a West Pointer, Episcopal clergyman, and lawyer, had made his office next door to Lincoln's Springfield, Illinois law office. Bledsoe became Assistant Secretary of War of the Confederate States

It was Lincoln's law partner, John Todd Stuart, who landed a West Point berth for a young soldier of promise. This young soldier was Confederate General George E. Pickett, whose name became inseparably linked with the battle of Gettysburg.


